What is this product?

Type

The Sub-fund is part of BA³ STRATEGIC INVESTMENT SICAV fund. The Fund is an open-ended investment company with variable capital, incorporated in the Grand Duchy of Luxembourg. This Fund is authorised and supervised by the CSSF. The Depositary is Banque Havilland S.A.

Term

The investment horizon is medium term and should be at least 3 years.

Objectives

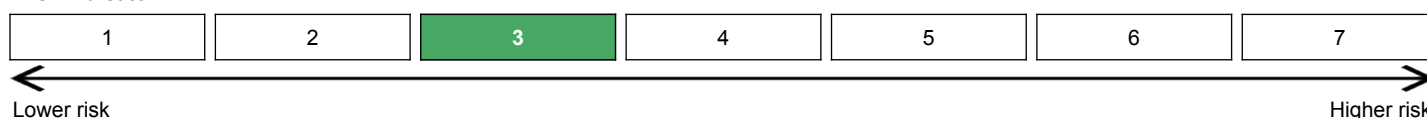
The Sub-Fund is a mixed actively managed fund of funds. The objective of the Sub-Fund is, in particular, to gain regular income by mainly investing through UCITS including ETFs with focus on environmental, social and governance (ESG) factors.

Intended retail investor

Reserved for retail and institutional investors. This Sub-Fund is addressed to investors seeking income with a conservative multi-asset allocation. Minimum Subscription: 1.000 EUR.

What are the risks and what could I get in return?

Risk Indicator:



The risk indicator assumes you keep the product for 3 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the fund is not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance over the last 10 years. Markets could develop very differently in the future.

The stress scenario shows what you might get back in extreme market circumstances.

Unfavourable scenario: This type of scenario occurred for an investment between 28/12/2021 and 28/12/2022 (If you exit after 1 year), 19/11/2021 and 21/02/2024 (If you exit after 3 years).

Moderate scenario: This type of scenario occurred for an investment between 26/12/2014 and 28/12/2015 (If you exit after 1 year), 04/08/2017 and 04/08/2020 (If you exit after 3 years).

Favourable scenario: This type of scenario occurred for an investment between 23/03/2020 and 23/03/2021 (If you exit after 1 year), 24/12/2018 and 24/12/2021 (If you exit after 3 years).

What happens if Adepa Asset Management S.A. is unable to pay out?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

Recommended holding period: 3 years

This fund has no minimum holding period, but has been created for medium term investment. You should therefore be prepared to remain invested with your investment for at least 3 years. However, you can return your investment on any bank business day in Luxembourg.
