What is this product?

Type
The Sub-fund is part of BA³ STRATEGIC INVESTMENT SICAV fund. The Fund is an open-ended investment company with variable capital, incorporated in the Grand Duchy of Luxembourg. This Fund is authorised and supervised by the CSSF. The Depositary is Banque Havilland S.A.

Term
The investment horizon is medium term and should be at least 5 years.

Objectives
The Sub-Fund is actively managed. The investment objective is to achieve medium term capital growth mainly through the direct investment in equities. The Sub-Fund combines a thematic approach and a quantitative equity selection approach within a multi-asset allocation strategy, unrelated to benchmark constraints. Both thematic and quantitative approach to equity selection are based on a fundamental analysis of companies, even though they use different drivers. The combination of the two approaches is an efficient solution to ensure a more stable long-term performance.

Intended retail investor
Reserved for retail and institutional investors. The investment strategy corresponds for the investors with a medium-high investment risk profile. Minimum Subscription: 1.000 EUR.

What are the risks and what could I get in return?

Risk Indicator:



The risk indicator assumes you keep the product for 5 years.

The stress scenario shows what you might get back in extreme market circumstances.

Unfavourable scenario: This type of scenario occurred for an investment between 28/12/2021 and 28/12/2022 (If you exit after 1 year), 23/03/2015 and 23/03/2020 (If you exit after 5 years).

Moderate scenario: This type of scenario occurred for an investment between 29/06/2017 and 29/06/2018 (If you exit after 1 year), 05/02/2015 and 05/02/2020 (If you exit after 5 years).

Favourable scenario: This type of scenario occurred for an investment between 23/03/2020 and 23/03/2021 (If you exit after 1 year), 11/02/2016 and 11/02/2021 (If you exit after 5 years).

What happens if Adepa Asset Management S.A. is unable to pay out?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

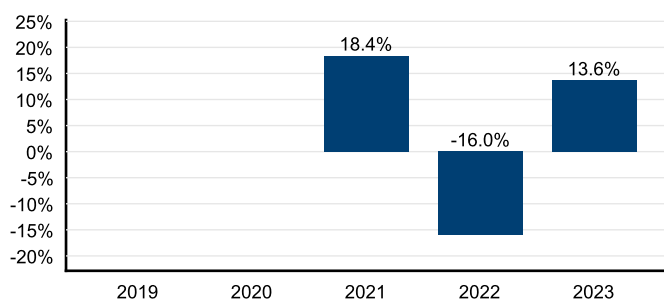
