The Sub-fund is part of BA<sup>3</sup> STRATEGIC INVESTMENT SICAV fund. The Fund is an open-ended investment company with variable capital, incorporated in the Grand Duchy of Luxembourg. This Fund is authorised and supervised by the CSSF. The Depositary is Banque Havilland S.A.

# Term

The investment horizon is medium term and should be at least 3 years.

# Objectives

The Sub-Fund is actively managed. The objective of the Sub-Fund is to seek medium to long-term capital appreciation, with medium volatility. The Sub-Fund seeks to achieve its objective by investing indirectly through multi-strategy and multi-asset class approaches. Multi-strategy approach refers to the possibility to diversify the sources of alpha by investing in different kind of investment strategies, whereas multi-asset class approach refers to the possibility to invest in different type of asset classes (through single asset market UCIs and/or multi-asset UCIs) in order to diversify the underlying market risks.

### Intended retail investor

Reserved for retail and institutional investors. The investment strategy corresponds for the investors with a medium investment risk profile. Minimum Subscription: 1.000 EUR.

### **Costs over Time**


