## What is this product?

### Type

The Sub-fund is part of BA<sup>3</sup> STRATEGIC INVESTMENT SICAV fund. The Fund is an open-ended investment company with variable capital, incorporated in the Grand Duchy of Luxembourg. This Fund is authorised and supervised by the CSSF. The Depositary is Banque Havilland S.A.

### Term

The investment horizon is medium term and should be at least 5 years.

### Objectives

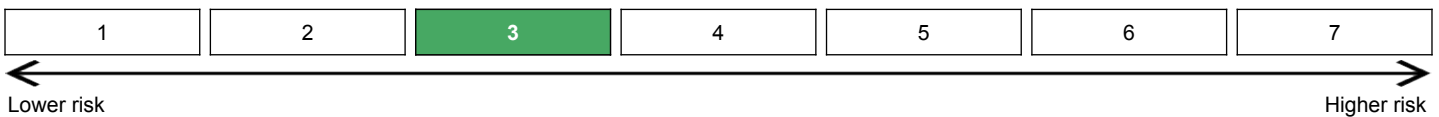
The investment objective of this Sub-Fund is to provide capital growth and income over the long term through investing in a diversified portfolio of assets with a focus on Asia. Within the Asia-focused portfolio, there will be a tilt towards Chinese assets over the long term.

### Intended retail investor

Reserved for retail and institutional investors. This actively managed Sub-fund is suitable for investors with a moderate risk tolerance who wish to invest in a diversified portfolio of funds of equities and bonds with a focus on Asia and a desire for capital appreciation and income over the long-term. Investors should be prepared to assume the risk associated with investing in equities, bonds, and their associated financial instruments in Asia.

## What are the risks and what could I get in return?

### Risk Indicator:



The risk indicator assumes you keep the product for 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the fund is not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

Moderate scenario: This type of scenario occurred for an investment between 27/01/2017 and 29/01/2018 (If you exit after 1 year), 26/09/2017 and 26/09/2022 (If you exit after 5 years).

Favourable scenario: This type of scenario occurred for an investment between 23/03/2020 and 23/03/2021 (If you exit after 1 year), 04/11/2016 and 05/11/2021 (If you exit after 5 years).

## What happens if Adepa Asset Management S.A. is unable to pay out?

### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

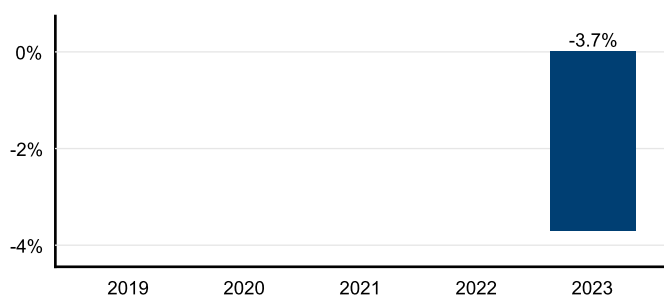
