What is this product?

Type

The Sub-fund is part of BA³ STRATEGIC INVESTMENT SICAV fund. The Fund is an open-ended investment company with variable capital, incorporated in the Grand Duchy of Luxembourg. This Fund is authorised and supervised by the CSSF. The Depositary is Banque Havilland S.A.

Term

The investment horizon is medium term and should be at least 5 years.

Objectives

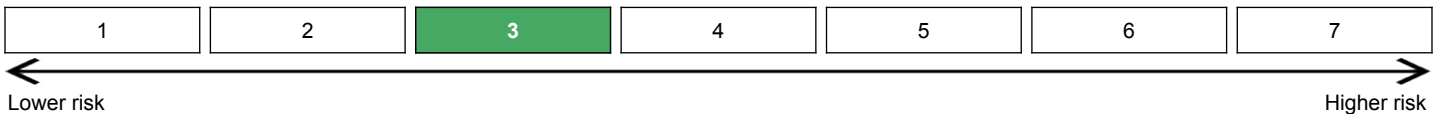
The Sub-Fund is actively managed. The objective of the Sub-Fund is to gain exposure to global equity and fixed income markets by mainly investing through UCITS including ETFs with focus on environmental, social and governance (ESG) factors with a best in class approach of the underlying investments. The financial product promotes environmental or social characteristics but does not have as its objective a sustainable investment.

Intended retail investor

Reserved for retail and institutional investors. This Sub-Fund is addressed to investors who intend to benefit from the global financial market trends with a medium level of volatility. The investment strategy corresponds for the investors with a medium investment risk profile. Minimum Subscription: 1.000 EUR.

What are the risks and what could I get in return?

Risk Indicator:



The risk indicator assumes you keep the product for 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the fund is not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

The stress scenario shows what you might get back in extreme market circumstances.

Unfavourable scenario: This type of scenario occurred for an investment between 29/12/2021 and 29/12/2022 (If you exit after 1 year), 19/11/2021 and 21/02/2024 (If you exit after 5 years).

Moderate scenario: This type of scenario occurred for an investment between 05/02/2021 and 07/02/2022 (If you exit after 1 year), 06/04/2017 and 06/04/2022 (If you exit after 5 years).

Favourable scenario: This type of scenario occurred for an investment between 23/03/2020 and 23/03/2021 (If you exit after 1 year), 04/11/2016 and 05/11/2021 (If you exit after 5 years).

What happens if Adepa Asset Management S.A. is unable to pay out?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

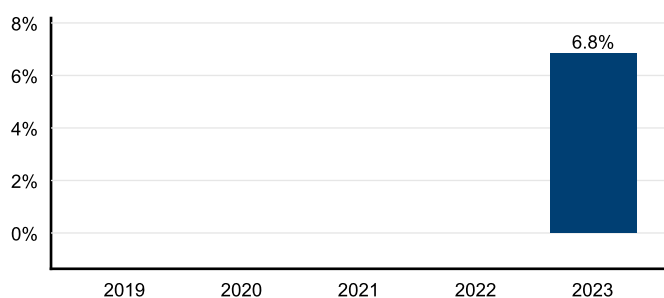
